# **University Boulevard Corridor Plan Explained at April Meeting**

Come to the next NFCCA meeting on 12 April 2023 to hear from Montgomery County Planning Department staff about the University Boulevard Corridor Plan (UBCP). Last fall, the planning department kicked off its public engagement process for developing the UBCP. The last Master Plan for Four Corners was issued in 1996.

The comprehensive UBCP will affect land use

and zoning recommendations (including allowing denser multifamily housing), transportation infrastructure improvements (pedestrian/bike/public transportation, etc.), and economic development in the Four Corners area. # **Ped-Xing Plan Prioritizes Improvements in 4 Corners**

The Pedestrian Master Plan (PMP) seeks to increase the comfort level, safety, and accessibility countywide for pedestrians (for the purposes of this article, "pedestrian" includes walkers, bicyclists, scooter riders, etc.). Also, the Montgomery County's "Vision Zero" goal is to eliminate transportation-related fatalities and severe injuries by 2030 by fundamentally changing how county roads are planned and designed and shifting from maximizing traffic volume efficiency "to ensuring that the transportation system is safe for all, regardless of travel mode."

The current PMP draft includes actionable, data-based recommendations for determining future pedestrian/bicycle capital investments. The goals are to develop a more comfortable, convenient, and connected pedestrian network while increasing safety. The PMP looked at how pedestrian amenities are designed and constructed, transportation engineering policies, and opportunities for traffic safety education. Some of the recommendations are: allowing more time to cross streets safely; making proactive, data-driven sidewalk construction and maintenance decisions; increasing places pedestrians can safely cross corridor roadways; and increasing Automated Traffic Enforcement locations.

The PMP evaluates specific factors such as the amount and width of sidewalks, as well as the distance of sidewalks from the road because speeding cars can make walking uncomfortable, the number of driveway crossings, and comfort factors such as shading by trees or buildings. At road crossings, factors affecting pedestrian comfort include traffic control, posted speed limit, number of lanes to cross, median type, and crosswalk type. The PMP noted that "Undesirable pathways are more likely to be along wider, faster roadways like Georgia Avenue or University Boulevard where landscape panels that buffer the sidewalk (if they exist at all) may not be sufficiently wide or have enough soil volume to support the growth of canopy trees."

The Four Corners area is characterized in the PM Plan as an urban and major transit corridor, because Colesville Road and University Boulevard run along its boundaries. With its many public transit options and high volume of traffic, the Four Corners area is particularly dangerous for pedestrians. Unsurprisingly, the PMP observes that, "Managing vehicle speed is an essential element in creating a high-quality pedestrian environment" and recommends installation of traffic calming measures, crosswalk markings, and other treatments."

Flash Bus Rapid Transit is already operating on Colesville Road and is planned for University Boulevard. The PMP observes, "As transit corridors such as Georgia Avenue, Veirs Mill Road, and University Boulevard account for 10 per-

cent of fatalities and severe injuries but only 1.3 percent of roadway miles, more frequent protected crossings and lower target speeds are needed on these roads to achieve Vision Zero." The PMP adds that. "Longer block lengths limit routing options for pedestrians and encourage crossing streets at unsafe places because protected crossing locations are spaced too far apart. Driveways create conflict points between cars and pedestrians."

The PMP found that 16 percent of severe and fatal pedestrian crashes take place at uncontrolled intersections and 37 percent of severe and fatal pedestrian crashes take place midblock. The Colesville Road and University Boulevard corridors merit more protected crossings to give public transit riders safer opportunities to cross when catching the bus.

In Town Centers with higher pedestrian activity such as Four Corners—the PMP calls for re-evaluating no-turn-on-red to protect pedestrians, implementing **Leading Pedestrian Intervals** (LPIs) at traffic lights to give pedestrians a head start, and reducing signal cycle lengths to make pedestrian travel more convenient and limit noncompliance when impatient pedestrians cross against the light. PMP also recognizes the need to manage dangerous driving behaviors with greater **Automated Traffic Enforce**ment (ATE), such as speed and red-light cameras.

Areas (BiPPA) program is one of the primary ways that the County Council funds pedestrian and bicycle improvements, such as new sidewalks and 10-foot-wide paths sidepaths for both pedestrians and bicyclists, improvements to meet Americans with Disabilities Act (ADA) requirements, crosswalks, and roadway changes to reduce motor vehicle travel speeds.

The PMP recommends priorities for BiPPA investments in areas with the greatest need. The road from downtown Silver Spring through Four Corners Town Center to Burnt Mills Town Center is designated as one of the highest priority BiPPA areas and this stretch of roadway is proposed to be *funded* in Montgomery County's Capital Budget.

Downtown Wheaton through Four Corners Town Center and east to Long Branch Town Center will receive consideration for improvements next as a Tier 1 BiPPA. Dennis Avenue from Georgia Avenue to University Blvd. and Lockwood Drive from Burnt Mills Town Center to White Oak Town Center are treated as Tier 2 BiPPAs. Arcola Avenue from Georgia Avenue to University Blvd. is listed as a Tier 3 BiPPA. These Tier 1 and 2 projects are prioritized to be undertaken later.

Adoption of the PMP recommendations to prioritize investments and make necessary policy changes will depend on actions by county and state agencies and elected officials as well as community input. The Montgomery County
Department of Transportation (MCDOT) and Maryland
Department of Transportation
will also play a pivotal role in
making decisions on prioritizing these infrastructure capital
projects. Also, the County
Council, which must approve
the capital budget, will have
the ultimate say on these expenditures.

The process for further

consideration of the draft PMP is already underway. The Montgomery County Planning Board held a public hearing on the Pedestrian Master Plan (PMP) on 23 March 2023 (after the deadline for newsletter articles). # **Bicycle Preparation Tips for Spring from the Pros**

As we gear up for our first community bicycle ride of 2023, it is definitely time to get out those bikes, dust 'em off, and get them prepared for use in the warmer months ahead. Before hopping onto the seat to take a ride, it is important to make sure your bicycle is in good working condition so that you stay as safe as possible.

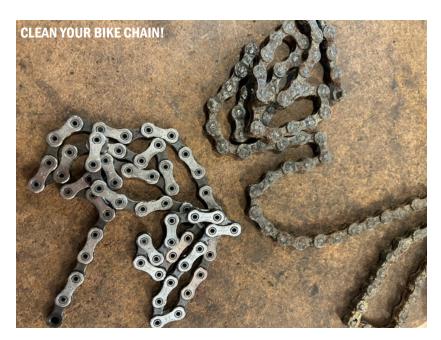
Local bicycle shop owners Linda Mack (of Silver Cycles in Silver Spring) and Bruce Sawtelle (of Takoma Bicycle in Takoma Park) are looking out for our safety and have these tips to share about preparing your bicycle for riding in the spring, particularly when it hasn't been used for some period of time.

Sawtelle suggests using the ABC Safety Check:

A is for AIR
B is for BRAKES
C is for CHAIN

AIR. "Make sure that the tires are pumped to the correct inflation pressure which is found on the side of the tires," says Sawtelle. Mack adds that the tires can crack when they are sitting on the ground for a long time, and they are more susceptible to pinch flats.

BRAKES. "You want to make sure your brakes work before you do anything," says Mack. Sawtelle emphasizes checking to make sure the brakes are working and can stop the bike. For bicycles that have been sitting for a while, a glaze can form on the brakes, causing them not to work very effectively. One tip



Mack offered was to loosen the brakes and sand the brake pads a couple times with sandpaper to create a rougher surface for the brake to grip the tire more effectively.

CHAIN. Sawtelle says, "Make sure the chain goes smoothly through the track and lubricate if needed." Lubricants reject dirt and keep chains clean. Using bicycle lubricant on the chains can also prevent rust. Mack emphasizes the need to use lubricants specifically made for use on bicycle chains, as other types of lubricants may collect dirt and cause the chain to grind away at the drivetrain. Once that's worn, it can go from a \$25 fix to a few hundreds of dollars when a drivetrain needs to be replaced.

Mack also encourages a thorough check of the shift cables. With lack of use, cables can gum up. Run the bicycle through all the shifting cycles before going out on an actual ride. Notice if there is any difficulty transitioning from gear to another one. If there is, that may be one sign indicating the need to lubricate or clean the chains. If the problem continues to happen, or can't be diagnosed, bringing your bicycle by a shop is a good idea. Proper maintenance is key.

Many bicyclers do get an annual spring inspection or full tune-up done on their bicycles. "People want an expert to look at it for peace of mind," says Sawtelle. Bicycle mechanics are very technical and it can take a specialist to make sure the gears and brakes are good to go and all the nuts and bolts on the bike are tight to ensure everything runs smoothly for the season. Takoma Bicycle offers tune-up estimates for free.

On the contrary, Mack says, "A lot of times people are afraid to bring the bike in because they think it will be really expensive." This is

not always the case, and she encourages people to bring their bikes in just to see if there may be any issues they may not be aware of. Mack says her staff doesn't mind if someone brings in a bike and asks the technician to look it over quickly. She said, "We like to do that and keep people riding and keep people safe."

Helmets are also very important to use when riding a bicycle, even if it's just around the neighborhood. Helmets have to be adjusted correctly and fit snugly around the head. This is especially crucial for growing children. Mack says the helmets should not be sitting on top of the

head, they need to be around the head and, if they no longer fit like this, it's time to get a bigger helmet.

During the cooler months of the year, if a bicycle needs a tune-up, a person can often get it back in a day or two. Of course, the warmer season extends this timeline. Mack says, "Once we start seeing temperatures in the 50s or 60s for a solid week, then the bikes come in fast." Major repair timelines shoot up from one day to up to three weeks. Takoma Bicvcle stavs busy April through October, with peak months being April, May, and June.

If you are going to prepare your bike to ride in our 22 April community bicycle ride, do it today! This way, you should have time to complete the ABC Safety Check and still have time to get your bicycle into the shop and tuned up if something more extensive needs to done to prepare it for riding. We want all of our neighbors to have fun and be safe whether off or on the bicycle this year.

# **Light Pollution and its Negative Impacts on Wildlife, Human Health**

Thinking of adding lights to your driveway to keep better track of your cars at night? Keeping your porch light on to feel safer around the house? The cost is small and bulbs last longer than ever, so why not? Yet while the introduction in recent years of cheaper light sources—such as LEDs has made it tempting to use more lighting for outdoor purposes, regular exposure to light during nighttime hours not only hurts wildlife, but also has a negative impact on humans.

#### The Problem for Wildlife

Artificial light causes several problems for wildlife, especially those animals that are nocturnal (active at night). This includes:

- Attracting different organisms (such as moths, frogs, and migratory birds) to places where they should **not be.** This concentration of animals in one location can result in greater predation and mortality. It also results in animals being trapped in the light, exhausting and sometimes killing them. One billion birds alone are killed EACH YEAR during fall and spring migrations because of building strikes, with the *brightest buildings having the* highest number of strikes.
- Repels many organisms from their normal habitats, resulting in hab-

itat loss. Frogs, for instance, can't relocate their vernal pool which is now under a bright light. Light pollution reduces insect visits by 62 percent, which further hurts pollinators already in decline. Moths, which are nocturnal pollinators, especially play an important role as pollinators in the ecosystem.

■ Changes the day and night patterns of organisms. This can alter reproductive cycles, not allow enough times for repairs to their bodies, and generally result in the organism not get-

ment formation, leaf shedding, bud dormancy, and behavior of pollinators. In the case of trees, those leaves closest to light sources stay on the longest, sometimes weeks longer, in the autumn months when the leaves of trees change color and fall. This could result in stressed plants and trees, or plants that do not grow properly.

#### **Human Impacts**

The damage from artificial light doesn't stop at wildlife. Humans, while feeling safer in locations that are lit, need darkness as well. Humans need dark conditions to produce melatonin, a hormone that is necessary for the body to repair its cells. Serious



ting enough sleep and being lethargic. This could mean they are not as healthy and at greater risk of predation.

In addition to wildlife, exposure to artificial light also impacts plants and trees. Different plants need different photoperiods, or certain lengths of night and sunlight, to grow properly. Increased light exposure impacts pig-

interruption to the circadian rhythm and day/night pattern interferes with this production and has been found to result in higher rates of some cancers. Artificial light exposure, especially at night, has also been linked to increased rates of insomnia, headaches, cardiovascular disease, diabetes, anxiety, obesity, depres-

#### The Rise of LEDS

LEDs (light-emitting diodes) have become widely available and popular over the last 15 years. Their popularity stems not only from their longevity but the fact that they use a fraction of the electricity as traditional incandescent light bulbs. However, not all LED light bulbs are great for humans and wildlife. LED light bulbs in the blue and purplerich wavelengths have been shown to pose serious risk to the environment and human health, as the longer wavelengths bounce around the sky and atmosphere, appearing brighter to wildlife, possibly even blinding them.

#### **What You Can Do Help**

If you must use artificial outdoor lighting, consider the following:

- Keep the light low, mounting the fixture as low to the ground as possible to avoid unnecessary light spread. Be a good neighbor and don't shine light right into your neighbor's bedroom window!
- Shield your light fixtures so that the bulb/light source cannot be seen. This cuts down on the amount of glare seen by animals, which results in less chances of them being trapped, repelled, or otherwise impacted by artificial light. Also, make sure the light points down.
- Make sure you're using lights designed for nighttime use. This includes wavelengths in the long range,

such as reds and oranges, as the light will appear dimmer to animals as opposed to other colors. Avoid blues and purples.

- Don't overdo it on wattage. Use only as much as you truly need. Extra light doesn't necessarily make you safer, as bright glares from lights results in darker shadows and actually makes it harder to see.
- Rethink your outdoor lighting. Do you really need to have your backyard lit all night, for instance? Can you eliminate any lighting?
- Do you need to have a light on all night? Can you turn off your porch light when you go to bed in the evenings? Especially consider this during fall and spring migrations to limit bird strikes.

# **Forest Knolls Pool Undergoing Renovations**

If you have walked through Northwest Branch recently, you may have noticed that the Forest Knolls pool is currently undergoing construction. This major repair work, which is being done by Lighthouse Pools, is expected to be completed in April. While some repairs have been made over the years, the pool has not undergone this level of reconstruction since it was built more than 60 years ago. Forest Knolls Pool Board President Jen Ritchotte stated that "the current work was necessary to keep the pool functional."

The construction project includes installation of a new main drain network, with new piping all around the pool underneath the deck, as well as a drain system so that the deck itself drains properly. In addition, a new pool deck will be installed, and the pool will be refreshed with LED lights, new tiles, and a fresh coat of paint. The Pool Board is also planning to install new sections of fencing and new pavilions.

Ritchotte indicated that, in addition to this construction, the pool parking lot is also currently being used as a staging area by Pepco and Intren, which are working together to complete a system of upgrades for several streets in our neighborhood. The upgrades include new poles, wires, and services. The pool parking lot is being used for delivery and storage of utility

poles. The project is expected to be completed by May.

The Forest Knolls Pool is a community-owned and -operated outdoor pool on Foxglove Lane, typically open from Memorial Day to Labor Day. It is a membership-based pool of 300 families. The pool is home to the Seahawks swim team, open to pool members ages 4–18, which competes in the Montgomery County Swim League, Division F. Swim lessons are available, but are currently limited to members.

Over the years, the Pool has hosted various events open to the community, including National Night Out, Spring-a-Pool-OOZA, and Octoberfest. This summer, the pool will again host food trucks in its parking lot, which are available to community members. There is currently a waitlist to join the pool.
